- 2- Bidders have to enclose receipt of Tender form fee payment (Rs. 1,180/- Inclusive GST) receipt along with the technical part of the bid. Tender form can be purchased from KMVN Head office, Car parking, Sukhatal, Nainital.
- 3- Bidders have to enclose in original Earnest money deposit (EMD) in form of Draft/FDR of Rs. 20,000/- made in favour of Managing Director Kumaon Mandal Vikas Nigam payable at Nainital, issued by a bank approved by RBI.
- 4- Bidder must have a minimum experience of 1 year of development/annual maintenance of website and online booking application manager of a hotel chain having 10 units.

Important Dates

Bids needs to be submitted at Kumaon Mandal Vikas Nigam Car parking office, Sukhatal, Nainital before the due date and time of submission of bids. Late received bids shall not be entertained.
- 3- Bids have to be submitted in two envelopes.
 - a- **Technical Bid Envelop**-This envelops shall contain all the documents as per tender document and as mentioned in technical bid form along with the technical bid form.
 - b- **Financial Bid Envelop**-This envelop shall contain only the financial bid page (price bid).
